#### **INITIATIVES**

The employment unit engaged in the following broad outreach initiatives in accordance with various elements of FCC Rule 73.2080(c)(2):

Participated in **job fairs** by station personnel who have substantial responsibility in making hiring decisions.

The Stations' Operations Manager participated in a Job Fair at the Fond du Lac Tribal and Community College, Cloquet, MN, March 13<sup>th</sup>, 2019.

The Stations' General Manager attended, and had a booth, at the Fond du Lac Reservation Spring Job Fair at Black Bear Casino Resort in Carlton, Minnesota. Literature was handed out explaining job duties and potential openings in the future at the radio stations. April 10<sup>th</sup>, 2019.

The Stations' General Manager and Operations Manager operated a booth at the annual Carlton County Fair where we handed out fliers and information concerning jobs and potential future openings at the radio stations, August 15-18<sup>th</sup>, 2019.

Cloquet Fall Harvest Job Fair at Community Memorial Hospital was held on Thursday, October 24<sup>th</sup>, 2019. Station's General Manager was on hand to talk about the radio industry and describe to potential future employees how the radio industry works.
